Rules: Current (2010) IJF rules (modified). Competitors are required to bring their own white and blue belts as recently approved by Texas Judo, Inc. All competitors must have at least a white gi and are encouraged to bring a blue gi as well. A match between two competitors with blue gis will not be permitted.

Method of Competition: Modified Double Elimination for 5 or more
Round Robin for 4 or fewer

Tournament Director may adjust weight categories if necessary for safety.

Match Duration:

All Junior matches are 3 minutes.

All Novice, Men's brown belt and Masters' matches are 3 minutes.

All Men's and Women's Black belt division matches are 5 minutes.

Medals for 2nd and 3rd place
